5. Represents shares held by Susan Feinstein, Mr. Feinstein's spouse. Mr. Feinstein disclaims beneficial ownership of such shares, except to the extent of his pecuniary interest therein.
6. Represents shares held by trusts for the benefit of Mr. Feinstein's family members. Mr. Feinstein disclaims beneficial ownership of such shares, except to the extent of his pecuniary interest therein.
7. Represents PSUs earned based upon the achievement of a performance-based test for these PSUs previously granted.
8. With certain exceptions, the PSUs vest in two equal annual installments commencing on May 10, 2017, subject to Mr. Feinstein's continued service to the Company on such dates.
9. With certain exceptions, the PSUs vest on May 12, 2018, subject to Mr. Feinstein's continued service to the Company on such date.
10. With certain exceptions, the PSUs vest in three equal annual installments commencing on May 11, 2016, subject to Mr. Feinstein's continued service to the Company on such dates.
